CODE OF CONDUCT

Welcome to Robinson Town Centre. To make your visit and that of your fellow visitors more pleasant, we kindly ask that you do not engage in any of the following conduct while in the center. If you do, you are violating the center's Code of Conduct, which may result in your expulsion from the center in addition to any other legal remedies that the center management may choose to exercise.

This center is **private property** and no rights shall accrue to the public by virtue of the public's entry into this mall or on mall property.

PLEASE REFRAIN FROM THE FOLLOWING WHILE IN THE CENTER

- 1. Violence, fighting, physical abuse or any action that could result in a substantial risk of physical harm to persons or property.
- 2. Threatening, annoying or harassing any person.
- 3. Engaging in obscene conduct, using obscene language, obscene gestures, or racial, religious or ethnic slurs.
- 4. Running, horseplay, skating, rollerblading, skateboarding, or any action that interferes with the free flow of traffic in the center and/or access to stores. Bicycles and Segways must be used in accordance with bicycle and vehicle safety rules.
- 5. Standing or walking in such a way as to cause inconvenience to others.
- 6. Littering, throwing, discarding, or depositing any paper, glass, or other matter of any kind anywhere except in designated trash receptacles.
- 7. Defacing, damaging, or destroying any real or personal property that is part of, or located in or on, the center, including writing, spraying, scratching, or otherwise affixing graffiti on such property.
- 8. Yelling, screaming, playing loud music, or similar behavior that creates noise of sufficient volume to interfere with the hearing or peace of the general public or center patrons.
- 9. Assembling, demonstrating, protesting, petitioning, parading, picketing, marching, walking abreast in groups and/or loitering for the purpose of disturbing the peace or any unlawful purpose, disrupting the shopping enjoyment of customers, or disrupting the intended business use of the center. No solicitations for charity without prior written permission of center management.

- 10. Distributing commercial advertising of any kind, offering samples of items that are sold or available for sale, or actually selling products or conducting surveys.
- 11. Bringing animals on mall property with the exception of animals in the company of persons trained to assist physically challenged patrons, those animals going to or from pet stores or photography studios or involved in center sponsored events.
- 12. Wearing no shirt or footwear.
- 13. Sitting on stairs, planters, or trash receptacles or any improper use of center amenities.
- 14. Bringing in alcohol or consuming alcohol anywhere other than in businesses permitted and licensed to sell alcoholic beverages.
- 15. Being intoxicated and/or possessing or being under the influence of illegal drugs.
- 16. Possessing an explosive or incendiary device of any kind (including fireworks).
- 17. Entering any area of the center not open to the public.
- 18. Truancy.
- 19. Violating any federal, state, or local laws, rules or ordinance.
- 20. Smoking. This center is a smoke-free environment. Smoking is permitted only in designated areas.
- 21. Overnight parking or commuter parking; parking in non-designated parking areas, parking in fire lanes or other no parking areas, erratic or careless driving, exceeding the posted speed limit, or use of a vehicle in manner inconsistent with shopping center traffic markings or signage. Parking violators may be subject to towing at the vehicle owner's expense.
